Job Title: Community Health Representative

Position Summary:

The Community Health Representative (CHR) plays a vital role in coordinating and supporting Tribal health programs, particularly in Purchased and Referred Care (PRC) services. This position provides technical assistance, policy interpretation, and program oversight to ensure compliance with PRC regulations and effective service delivery. Additionally, the CHR supports health education initiatives, including Medicare/Medicaid enrollment and outreach, to improve community health outcomes.

Key Responsibilities:

Purchased and Referred Care (PRC) Services Coordination:

- Provide consultation and technical assistance on PRC services to support Tribal health programs.
- Interpret and apply PRC regulations, policies, and allocation methods.
- Respond to inter-governmental inquiries regarding PRC concerns, service areas, and beneficiary access.
- Assist in staff orientation, data collection, quality assurance, and overall PRC program management.

Health Education & Outreach:

- Develop and implement health education programs to promote wellness and disease prevention.
- Conduct outreach efforts to increase community awareness and participation in healthcare services.
- Assist individuals with Medicare/Medicaid enrollment and provide guidance on available benefits.
- Collaborate with healthcare providers and community organizations to enhance health education initiatives.

Qualifications:

- **Education:** Minimum of an Associate degree required; Bachelor's degree preferred in Public Health, Healthcare Administration, or a related field.
- Experience: Experience in healthcare coordination, patient advocacy, or health education.
- Knowledge: Understanding of PRC regulations and Tribal health programs preferred.
- Skills: Strong communication, organizational, and problem-solving skills.
- Cultural Competency: Ability to engage with diverse populations and provide culturally competent care.
- Additional Requirements: Must possess a valid driver's license and reliable transportation.
 Employment is contingent upon the successful completion of a background check and drug screening.
